Students in grades 9-12 also participate in two lessons supplied by the Madison County Health Department. Theses lessons were presented during the students' first period class on specified dates.

All 6th, 7th, and 8th grade students are assigned to a daily critical thinking skills class. The district has developed a calendar and specific lessons to present on the specified days. School leaders are able to monitor and document the instruction being provided.

Ninth through 12th grade students go to homeroom one day of each month. During that homeroom time all students participate in a lesson written by Madison County mental health counselors.

The lessons have been developed by district personnel using resources such as LEAPS (Social Emotional Learning for Schools) curriculum as well as materials from the Florida Department of Health.
